BACKGROUND:

The Client is of the opinion that the instructor has the necessary qualifications, experience & abilities to provide services to the Student. The Instructor is agreeable to providing such services to the Student on the terms and conditions set out in this agreement. This contract services both the Client/Student & the Instructor of Melody Piano Detroit.

IN CONSIDERATION OF the matters described above, the mutual benefits & obligations set forth in this agreement, the receipt & sufficiency of which consideration is hereby acknowledged, the parties to this agreement s agree as follows:

Makeup Lessons

Melody Piano Detroit holds make-up lessons on Fridays. If a lesson is canceled, the client is responsible to arrange make-up lesson time with instructor (Suzan Pleva) at time of cancellation. If said make-up lesson is not arranged, the client will be charged for the canceled lesson.

Services Provided

- The instructor will provide services consisting of piano lessons for _____
- Lessons are agreed by both parties to be held once a week on said date and time _____

Term Agreement

End date of agreement is indefinite. There must be a month advance formal notice of termination of contract established by the client and or instructor in writing. Both parties must agree on said date. If lessons are terminated without this month's confirmed, in writing notice, client will be charged that month's tuition fee cycle.

Compensation

- Tuition fees are to be paid monthly. Tuition is due on the first day of every month. If tuition is not paid by the 3rd of the month, a late fee of \$45.00 will be applied
- Monthly Tuition Fee is \$____.00 which is a recurring charge
- Personal checks, cash, Venmo, and credit cards are accepted methods of payment
- ***Instructor is to be reimbursed for all materials and expenses***

Additional Clauses

Instructor is to be notified of any cancellations no less than 48 hours prior to scheduled appointment. If not, Client will be charged for missed lessons. A \$35.00 penalty fee will be applied/billed to the client for returned tuition checks, and a \$45.00 penalty fee will be applied/billed for late tuition payments. Tuition is considered late on the 3rd of the month. Students/Clients have the option to be billed for tuition in increments of either monthly, 3 month, 6 month, and yearly tuition billing cycles. If Student/Client does not request or specify, they will automatically be billed monthly for tuition.
